Important note:

The expansion of telehealth during the COVID-19 pandemic has put a large strain on various telehealth networks and software resulting in some changes in pricing options. Some free options are no longer available. Reach out to vendors directly to learn more about their pricing and current offerings.

Key Considerations when selecting a telehealth vendor:

- ◆ How many connections/users will you need?
- ◆ Review available bandwidth and existing IT/HIT infrastructure - Include IT team in the process.
- ◆ Evaluate the needs of your patients and community - Where can telehealth be used in your practice?
- ◆ Is this vendor HIPAA Compliant? Are BAAs available?
- ◆ Contracting and commitments - Look at the long-term requirements of vendor contracts.
- ◆ Reach out to vendors for demos and detailed information.

Electronic Health Record (EHR) Integration - Many EHRs have a built-in telemedicine function to initiate visits with patients. Review your EHR and its functions (if they offer a module or easily integrate) before exploring other vendors! Here is a list of several EHRs with telemedicine functionality:
